1. With the exception of Process Sheets and Time Cards, there will be no printed copies of paperwork available at the event – you must print your own paperwork.
2. You should already have received: Final Instructions (Competitor's Bulletin 1) and a link to the Road Book.
3. The stage plans in the first version of the Road Book showed too many radios. If you downloaded a copy of the Road Book before 01:35 on 28th June, you should delete the extra radios on the stage plans. The mandatory radios (the only ones that should be shown on the stage plan) are at the stage start, posts 4, 8, 10, 13, 14, 17, and the stop line
4. **Secretary of the Meeting:** Ian Sadofsky is now unable to be at the rally because of family illness. The Secretary of the Meeting is now David James. However, for any problems on the way to the venue, please still contact Ian Sadofsky on **07842 417275**.
5. **SR9:** We are not issuing individual times for Scrutineering. Saturday scrutineering is from 14:00 to 18:00; Sunday scrutineering is from 06:00 to 08:00 (but only for those that have requested Sunday scrutineering). If you have not requested Sunday scrutineering and now need to scrutineer on Sunday, you must contact us.
6. **Judges of Fact:** The following are named as Judges of Fact for failure to comply with GR R.25.6 (correct route on stages, reversing back to stop line, reverse direction on stage), false starts on a stage, unauthorised possession of pace notes, unauthorised servicing, unauthorised smoking, excessive noise & backfiring, crash helmet, seat belt, FHR and overalls regulations, misuse of SOS/OK cards, depositing of litter:

8. **MTC2** is the control at the end of the rally and R 30.3.3 applies: "30.3.3. At the end of a Rally or of any day of a Rally Competitors are allowed to check in in advance of their due time. ... Competitors arriving early must have their due time entered on the Time Card; those arriving later than their due time must have their actual time of arrival entered."
9. We are running these rallies later in the year than we usually do. The area surrounding the tracks is likely to be very dry. Please take care with any naked flames not to start any unintended fires and remember that there will be a lot of flammable materials in the service area.
